Minutes of the meeting held on Monday 20 February 2006 at 7.30pm in the Village Hall

Minutes

The minutes of the meetings held on 16th January 2006 were agreed as a true record and signed.

Declarations of Interest None apparent.

PC Seweli was introduced to the meeting and outlined his role in the recent reorganisation of the Humberside Police Force. He explained that there were now three categories incident response, volume crime team and neighbourhood. This would differ from before and they would be left to deal with incidents in the neighbourhood and the community issues. A better police presence would be shown with one sergeant and three officers covering South Ferriby and other villages. Any problems could be e-mailed to him, only those incidents relating to the community, and other crime related incidents would be dealt with in the usual way. Telephone and contact list of members to be forwarded. PC Sewell was thanked for his visit and left the meeting.

Matters Arising

Beulah Fields Cllr Berry had taken the quote to Mr Whyatt at Cemex and a letter had been completed as requested including a location map. Mr Whyatt was happy to support the request and would put to committee. Other grants discussed, Mr Fisher to complete.

Path to Horkstow Reply received from Mr Norvak explaining that the councils request had been noted but he was not optimistic that the footpath link would be provided in the foreseeable future but would keep the parish council advised.

Flood Plan Cllr Haddon reported that the survey had been distributed with 122 forms handed out and 54 returned to date. The responses would be collated and hopefully completed soon.

Give Way sign Post Office Lane/High Street to be replaced along with sub plate.

Footpath Sluice Road weeds breaking through and breaking up - reported to be passed to Mr Whincup.

Prospect Villas sign not on side house any more - Mr Hill would make enquiries but up to householders.

Horkstow Road sign missing - reported.

Footpath Sluice Road/Low Street junction - reported.

Planning

App No 2005/1048 Permission for the tipping of cement kiln dust (CKD) and inert factory waste above existing approved levels. Cemex Cement South Ferriby Cement Works Sluice Road. Cllr Haddon reported that she had had meetings with Cemex and spoken

to the planning officer regarding this and handed out a suggested objection (attached to minutes) to the application with an amendment that they approve cell 1 and 2. Mr Groombridge was present at the meeting as a member of the public and was integrated into the meeting with the approval of all those present. A full discussion took place, Cllr Holloway wished it to be recorded that he was not happy with the proposals of Cemex and the amount of waste put into the area. Cllr Leaning proposed that Cllr Haddon's proposals/objections be forwarded to the planning officer for inclusion, seconded by Cllr Fisher all those present were in agreement bar Cllr Holloway. Carried that these proposals be forwarded. Cllr Haddon informed the meeting that she was happy to attend liaison meetings in the future and report back to the council. All other issues regarding Cemex to be put before the liaison meeting.
