### Public Participation

- NLC have confirmed that they are not prepared to adopt the PC bus shelter. However, if the PC purchases a new one from NLC, they will maintain that. A cantilever shelter (back and roof) is approximately £4,200 (including installation). An enclosed shelter (back, sides and roof) is approximately £5,250 (including installation). A metal perch seat is an extra £300. There would be an additional cost for dismantling and removal of the existing bus shelter. Agenda for next month.

## 100417/6 Casual Vacancies

It was discussed and resolved to co-opt Sharron Sibson. Sharron Sibson and the Clerk signed the Declaration of Acceptance of Office.

## 100417/7 Police Matters/NATS

- Humberside Police response to the London Terror attack 22/03/2017 was noted.
- Cllr Haddon observed that Hull would be vulnerable to a terror attack as there are no bollards in place.

## 100417/8 Cemex Liaison

- a) Due to a filter failure, there was a dust event on the 17<sup>th</sup>/18<sup>th</sup> March 2017, although Cemex did not receive any calls about it. Results from the air monitor have not been analysed.

There is a liaison meeting at the end of April 2017 with flood protection issues likely to be discussed.

Damian Marsden, Engineering Development Manager, will attend the May 2017 meeting to discuss a proposal for the new offices.

There have been recent reports of excessive noise, although a noise management survey suggests that noise overall has diminished. Further update will be sought at April's liaison meeting.

- b) The Cemex report and updated contact list was noted.

## 100417/9 Assets of Community Value

The PC has received official notification from NLC that Lewis Dillon, owner of The Nelthorpe Arms has confirmed his intention to sell. Initially there is an interim moratorium period of six weeks, during which an eligible 'community interest group' can submit a written request to be treated as a potential bidder for the property. This interim moratorium commenced on the 30 March 2017 and ends on the 10<sup>th</sup> May 2017. If such a request is received then the next stage commences, but if no such request is received then the owner is free to sell the property. The full moratorium period of six months is triggered if a valid written request is received. This period is intended to give the community group time to assemble a bid and, if successful, complete the purchase. However, the owner is not obliged to sell to the community group. The full moratorium period will end on 29<sup>th</sup> September 2017.

Cllr Holloway will place a notice on the notice board and the village Facebook page.

## 100417/10 South Ferriby Flood Defence Works

Cllr Holloway attended a meeting on the 4<sup>th</sup> April 2017. The Environment Agency (EA) confirmed that there are 4/5 projects viable, dependent upon private sector funding. Cllr Haddon understands that the EA are talking to Cemex at a senior level. Cllr Holloway confirmed that funds should be in place by the end of the year. A Flood Liaison Officer has been appointed to raise funds. Cllr Heathfield enquired as to the cost of the erection of the flood barrier in January 2017.
