### **Report from Ward Councillors**

- a) Ward councillors to update the Parish Council on activities within North Lincolnshire Council.

Cllr Sherwood reported that:

- Applications for In Bloom grants would be circulated shortly with a closing date of the end of April.
- Air fryers are being distributed in Brigg this week then in the villages afterwards. Courses in their use have now started.
- Scunthorpe will have the UK's first street velodrome in Church Square on 22<sup>nd</sup> March from 11am to 4pm. Bikes and safety equipment are supplied.
- The Diagnostic Centre is now open and people who would normally go to hospital for scans can now have appointments there. Up to 160,000 a year are expected.

Cllr Waltham reported:

- A large AI company plans to build four centres in the area, starting with South Killingholme and providing up to 16000 jobs in technology.
- A paper on local government restructuring in 2028 is being produced next week and will list the different options.
- Work on Barton by-pass is scheduled to start in June or July.
- The Humber Bank footpath is still ongoing. It is a technical job and NLC is short of officers so it is likely to be a couple of years before it is settled.
- The Local Plan has had to be re-issued as the housing target has changed again. NLC has 12 months to complete it.

## 24/25 –0306 Highways and Footpaths

**A reply had been received from Mick Johnson of Highways who is monitoring the situation and looking at treatment work at the junction. Cllr Waltham asked for it to be forwarded to him.**

iii) Update on conveyor safety concerns

**Cllr Waltham had received a response from Cemex stating that the structure over the road is safe.**
